NOTIFICATION

No.TMV/E-739019/61 : Whereas a disciplinary proceeding against Shri Rafiquez Zaman, Enforcement Inspector, currently attached to the office of the District Transport Officer, West Karbi Anglong, is contemplated/pending for his alleged persistent irregularity, unauthorized absence and dereliction of election duty reported by the District Transport Officer, West Karbi Anglong, received vide No. CT/E-219807/2632 dated 07-04-2026; and

Whereas it has been reported that the officer failed to perform mandatory duties related to the General Assam Assembly Election, 2026, despite repeated instructions, and has been persistently irregular in attending office since reporting for duty on 11/02/2026;

Whereas the Governor is satisfied that it is necessary and expedient in the interest of public service to place Shri Rafiquez Zaman, Enforcement Inspector, in the office of the District Transport Officer, West Karbi Anglong under suspension immediately.

The Governor of Assam, therefore, in exercise of powers conferred by Sub-rule-1 of Rule-6 of the Assam Services (Discipline & Appeal) Rules, 1964 hereby places Shri Rafiquez Zaman, Enforcement Inspector, in the office of the District Transport Officer, West Karbi Anglong under suspension with immediate effect.

It is further ordered that during the period that this suspension order shall remain in force, the headquarters of Shri Rafiquez Zaman shall be Office of the Commissioner of Transport, Paribahan Bhawan, Jawahar Nagar, Khanapara, Guwahati-22 and said Shri Rafiquez Zaman shall not leave headquarters without obtaining the prior permission of the undersigned.
