**Sub: - Fixation of Maximum rates of hiring charges of vehicles
For General Assam Legislative Assembly Election, 2026
only.**

In supersession of all earlier Office Memorandum regarding fixation of rates of hiring of vehicles and in pursuance of section 4 of the Assam Requisition and Control of Vehicle Act.1968 (Assam Act. V of 1969) the maximum rates of hiring of the different categories of vehicles per diem and the daily allowances of driver and handyman, is hereby fixed as given below with immediate effect for **General Assam Legislative Assembly Election, 2026 only**

The taxes as applicable shall be extra.

1. The daily allowance for driver of the vehicles will be Rs. 500.00 (Rupees Five Hundred) only and that of conductor/ handyman will be Rs. 400.00 (Rupees Four Hundred) only
2. Daily Allowance will be admissible for Driver and handyman only for HMV and MMV, handyman will not be allowed in case of LMV.

The following terms and condition shall apply in hiring of vehicles for the public purpose mentioned above.

1. The hiring authority will ensure that vehicle in good conditions are hired for election duties.
2. All the steps for proper recording of election related journey through use of GPS and other modern tools and other documentation be ensured to avoid false or excessive billing.
3. Vehicles taken on hire only be used for Election related works and be released immediately after that.
4. Bills related to the hired vehicles will be processed, certified and approved for payment in all cases by 30th May, 2026. No bill after this date be entertained at any level.
5. Under no circumstances a vehicle shall be hired an-route while the passengers are on board.
6. While hiring of vehicles, as far as practicable, vehicles from other States should not be hired. If, however, such vehicles are hired they shall be entitled for payment as per hiring rates applicable in their States.
7. While hiring a vehicle, the hiring authority will ensure that the vehicle is properly insured so that the owner can claim damages from Insurance Companies in case of accident etc.
8. Hiring authority will not incur any expenditure for repairing of the hired vehicle.
