ORDERS BY THE GOVERNOR OF ASSAM NOTIFICATION

No. TMV/E-333169/8 : Whereas Fitness certificate is required to ensure fitness of vehicle as unfit vehicle could be danger to Public Safety, same way Pollution Under Control Certificate is required for keeping pollution under control.

Whereas arrear is pending for MV Tax/Fee/Fine against many vehicles, making them non eligible for renewing these required certificates. Hence, in the interest of Public Safety, one time opportunity is given to the vehicle owners, who are having pending arrear MV Tax/Fee/Fine of more than 2 years as on 31.03.2023, to clear their dues with a waiver as per mentioned matrix, and to make their required vehicular documents up-to-date and valid, within the specified period of three months.

Therefore, in the interest of public safety and in exercise of the powers conferred on the State Government by Section 3 of the Assam Motor Vehicle Taxation Act 1936, the Governor of Assam is pleased to notify the following:

- 1. One-Time Settlement scheme to provide an opportunity to all the owners of tax defaulting vehicles having pending arrear dues of more than 2 years as on 31.03.2023 to update/renew all their vehicular documents by clearing their outstanding arrear dues (which includes due MV arrear tax as well as the per day late fine on delayed payment of tax) at the following specified rates for a period of 3 months w.e.f. from 15th August 2023,
 - a. If the tax defaulter comes forward to pay outstanding arrear dues within the period of first 30 days from 15th August 2023, 50% waiver on his all-outstanding arrear dues shall be given.
 - b. If the tax defaulter comes forward to pay outstanding arrear dues after the first 30 days (i.e., between 30 to 60 days) from 15th August 2023, 30% waiver on his all outstanding arrear dues shall be given.
 - c. If the tax defaulter comes forward to pay outstanding arrear dues after elapse of the period of first 60 days (i.e. between 60 to 90 days) 15th August 2023, 20% waiver on his all outstanding arrear dues shall be given.
- 2. Such tax defaulters can "pay the MV tax" in online mode at www.parivahan.gov.in or from his mobile phone at NextGen mParivahan App or by visiting their nearest CSC.
- 3. After payment of Arrear MV dues, the owners of such vehicles shall ensure updating/renewing all other required vehicular documents as per MV Act and rules , like the Fitness Certificate, Insurance Certificate, Permit, Pollution Under Control Certificate immediately before plying the vehicle on road.

- 4. Tax defaulters availing benefit under this scheme can also avail the benefit of the One Time Settlement scheme with reduced per day late fee on delayed renewal of fitness certificate to be in force for 2 months w.e.f. 15th July 2023.
- 6. If such tax defaulters still do not come forward to clear their outstanding arrear dues within the scheme period of 3 months or found plying without up-to-date and valid vehicular documents like fitness certificate even after payment of Arrear dues, such vehicles shall be seized immediately wherever found and may be auctioned as per procedure prescribed in Rule 109A of the Assam Motor Vehicle Rules 2003, as amended and "Revenue recovery mechanism" as specified in the Assam Motor Vehicle Taxation Act 1936 shall be invoked for 100% of their outstanding dues.

The order comes into force with effect from 15th August 2023.
