ORDERS BY THE GOVERNOR OF ASSAM

NOTIFICATION

No.TMV/E-333333/11 : In regards of vehicle scrapped by the owners without intimation to the Registering Authority and due cancellation of RCs due to their ignorance;

Whereas arrear dues against such already scrapped vehicles keep on accumulating for non-cancellation of RC in Vahan software.

Whereas due to accumulation of day to the day fines on arrear dues against their non-existent vehicles such vehicle owners are unable to cancel their RC

Therefore, to provide a One-Time opportunity to such vehicle owners to cancel their RCs along with clearing of arrears dues against their already scrapped vehicles, the Governor of Assam in exercise of the power conferred on the State Government by Section 3 of the Assam Motor Vehicle Taxation Act 1936 is pleased to introduce a One-Time settlement scheme as follows:

- 1. All the owners of tax defaulting vehicles, who has already scrapped their vehicles before 18th July 2022 (i.e. before the implementation of the Vehicle Scrappage Policy of Assam 2022) can apply under the Scheme for cancellation of their RC within the period of 3 months from the effective date of notification as per the prescribed procedure mentioned below.
- A. Such vehicle owner can settle their prayer for RC cancellation against their vehicle, Scrapped before 18.07.2022 by;
 - i. With payment of only 25% of total outstanding dues/liabilities (MV tax arrear, MV tax arrear fine, and fitness late fee etc.) in case of **transport** vehicle
 - ii. With payment of only 25% of total outstanding dues/liabilities (MV tax arrear, MV tax arrear fine and Green Tax etc., as applicable) in case of **non-transport** vehicle.
- B. Such owners can make an application for RC cancellation along with a notarised affidavit as attached at **ANNEXURE** -A to the concerned registering authority where the vehicle is registered with the following declaration clearly specifying that,
 - i. He/she, being the registered owner of the vehicle scrapped the vehicle already before 18th July 2022 and desire to settle the case by cancellation of RC by making necessary payment.

- ii. the vehicle was not stolen nor it had any involvement in criminal activities and there is no any hypothecation agreement liability to any financer against the said vehicle.
- iii. in case the vehicle declared to be scrapped by the owner is detected physically at any time on road or anywhere, owner to pay not only 100% tax/fees till the date of detection, after deducting the amount paid now for settlement for RC cancellation, but also liable to face any legal consequences as per law.
- C. DTOs shall take necessary step to cancel the RC based on the notarized affidavit and keep record of all subject vehicles for further references and to submit action taken

The order comes into force with effect from 1st August 2023 for period of three months.
