Sub - Govt. approval of revised HSRP rate & Additional cost of fixation of
HSRP at Vehicles Dealer's Point.

Sir,

With reference to the subject mentioned, I write to convey to you that Government vide letter NO TMV 160/99/pt-I/2285 dated 16th May 2015 has approved the revised rates for HSRP as per the rates determined by the Tender Evaluation Committee. Accordingly, the revised rates of HSRP category wise at the RTO (DTO premises) shall be as follows:-

Revised rates of price of HSRP- category wise at RTO premises

4	Heavy Motor Vehicles (HMV)	Rs.295/-	Rs.380/-

N:B-Applicable rate for one complete set of HSRP including 3rd Registration plate sticker for a vehicle.

In addition to the above, for fixation of HSRP at the authorized Dealers Point which is optional, an additional cost of Rs.300/- being the service/operational cost may be charged by the Dealers from the customers who opt to get the HSRP affixed at the authorized Dealers point premises subject to the condition that the HSRP shall be affixed within a period of 30 hours.

As per recommendation of the Tender Evaluation Committee, regarding choice for the vehicle owners either to affix the HSRP at the RTO premises or affix the HSRP at the vehicle dealers point, it was decided that HSRP fixation at authorized vehicle dealers end will be an optional service

Replacement of HSRP (for damage or any other reasons).

For replacement also, the vehicle owners will have a choice of either affixing the replacement HSRP at the RTO premises as per basic rates mentioned above or affix the replacement HSRP at the respective authorized vehicle dealers point, by paying an additional Rs.300/- over the basic price for complete set of HSRP. The rates for HSRP, are subject to levying of taxes in vogue, namely vat, service-tax etc

The revised rates may be given effect from 1st July, 2015
