

Guidelines for “*Mukhyamantrir Grammya Paribahan Achoni*” - CM’s Subsidy Scheme to Entrepreneurs/ Self Help Groups to start ‘Light Passenger Vehicle’ transport service in villages of Assam

Introduction

To improve rural connectivity in the villages of Assam, Hon’ble Chief Minister, Assam announced a scheme which may perhaps be introduced as “*Mukhyamantrir Grammya Paribahan Achoni*” to provide assistance to Entrepreneurs / Self Help Groups desirous of starting ‘Light Passenger Vehicle’(under the category of Light Motor Vehicle) transport services to connect the villages with nearest town / circle headquarter / block headquarter.

Objective

Objective is to improve rural connectivity together with self-employment opportunities to the entrepreneur residing in rural areas.

Coverage

As per the announcement by the Hon’ble Chief Minister, Assam, 10,000 villages are to be covered under the scheme. One beneficiary / registered Self Help Group per village to be covered and to be provided subsidy assistance to the extent of 25% of the cost of the vehicle or Rs. 1 lakh whichever is less.

Implementing Agency

The scheme shall be implemented at the district level by the District Level Committee. There shall be a District Level committee at the district level with the following members:

Financial Outlay

- There shall be a subsidy of Rs. 100 Crore. Maximum subsidy to the extent of 25% of the vehicle cost or Rs 1 Lakh whichever is less.
- There shall be a provision @ 2% of the total project cost for meeting the administrative expenses like printing of forms and brochures, advertisement, publicity (which may include meetings at block level, district level) and organization of district level function.
- The exact distribution of administrative expenses shall be determined based on the target of the district.

Eligibility Criteria

- The applicant / SHG must belong to the village for which he/she is applying for.
- The applicant must possess a valid driving license for operating the Light Passenger Vehicle (under the category of Light Motor Vehicle). For SHG, the member who will be operating the vehicle must possess valid driving license as mentioned above.
- The age of the applicant should not be less than 21 and not more than 40 years (as on 01.01.2020).
- For SHG, the member who will be operating the vehicle should not be less than 21 and not more than 40 years of age (as on 01.01.2020).
- Only one applicant from one (same) family will be eligible for assistance.
- The selected beneficiary / SHG shall be provided with subsidy after they make arrangement for payment of balance amount of the cost of the vehicle including his contribution of minimum 5% of the total amount, in case the beneficiary avails bank loan.
- Further the applicant needs to complete all the formalities as per the mandate of Central Motor Vehicle Act, 1988 and Central Motor Vehicle Rules, 1989.

Modalities of Execution

- The scheme guidelines, application form & list of approved Light Passenger Vehicle will be available on the official website www.comtransport.assam.gov.in
- The applications will be scrutinized by the district level committee for finalizing the successful applicant / SHG per village in the district.
- The finalized applicant / SHG will be communicated about the selection and will be issued sanction letter to proceed for purchase of the vehicle from the list of vehicles mentioned in the official website.
- The District Level Committee shall obtain the bank account details of the concerned dealers for transferring the subsidy amount by way of NEFT / RTGS on receipt of certificate from the DTO and submit the same to Commissioner of Transport, Assam.
- The selected applicant / SHG will be required to make arrangement on their own or from bank or other financial institutions for the balance amount of fund required over and above the assistance provided by the Government. No guarantee will be provided by the state government. The state government shall not have any financial obligation or liability towards the beneficiary / SHG after the vehicle is purchased and run on commercial basis.
- Minimum beneficiary's contribution will be 5% of the cost of vehicle if he/she avails bank loan.
- The state government shall not have any financial obligation or liability for any vehicle taxes, insurance, registration, etc. for the entire life of vehicle as per the provisions of CMV Act, 1988 and CMVR, 1989.
- The applicant / SHG on receipt of the vehicle shall immediately apply to the Regional Transport Authority (RTA) for obtaining the permit for plying the vehicle.
- The District Level Committee shall ensure maintaining the database pertaining to the vehicles provided to the successful applicant / SHG.

Important Points

- After purchase of the vehicle, its day-to-day maintenance and operation on commercial basis will be carried out by the individual beneficiaries / SHG without any intervention by any other authority / agency. However, if and when situation arises for any direct / specific intervention by the state government, in that case, the state government shall take such steps or measures as may be considered necessary in public interest.
- The beneficiaries / SHG will be the rightful and legal owner of the vehicles.
- The vehicles have to be registered as commercial vehicle only.
- The vehicles supplied under the instant scheme shall not be allowed to be sold / transferred within a period of 36 months from the date of delivery of said vehicle.
- The vehicles must be used for transportation of passengers only and the owners shall also abide by CMV Act, 1988 and CMVR, 1989.
- Application will be received in DTO offices.

Tentative Timeline

- Last date of receiving applications by District Level Committee on 16/03/2020.
